Many FLOs have tuition and/or travel costs that range from \$50 to \$3,000 depending on the magnitude of the FLO, its location, and duration. Last year we supported 126 students with partial, needs-based financial assistance to attend FLOs. The process for acquiring financial assistance mirrors the processes students and their families will encounter when applying for financial aid and scholarships for college.
