Many Fantastic Learning Opportunities or FLO's have tuition and/or travel costs that range from \$50 to \$3,000 depending on the magnitude of the FLO, its location and duration. DiscoverU enabled 528 FLO experiences to be possible for 458 individual students. The process for acquiring financial assistance mirrors the processes students and their families will encounter when applying for financial aid and scholarships for college. To ensure students gain the full benefit of FLO participation, DiscoverU supports FLO Coordinators with comprehensive training and technical assistance, to educate students about FLO's, support their application and successful completion of FLO's, and leverage their experiences to prepare for college.
